Dumpsters Will Be At The Following Locations:

- Abell: 31st & Abell
- Charles Village: NE corner of 27th & Maryland
- Harwood: NW Barclay & 27th Streets

Trash Baskets: Empty & maintain 85 CVCBD trash baskets 365 days per year, 7 days a week in the morning and evening during the week, morning or evening on Saturday and Sunday.

Street Sweeping: Sweep all District sidewalks and gutters at least 2 times a week (weather permitting).

Fall Leaf Removal Campaign: Assist residents in the timely removal of fall leaves October-December.

Crab Grass Removal Campaign: Assist residents in the timely removal of crab grass from the corner gutters in the spring and summer.

Bulk Trash: Patrol alleys at least 2 days a week and remove bulk trash items such as tables and chairs (but not construction material, tires, toxic waste, mattresses, or items subject to bed bug infestation).

Alley Cleaning: Routinely clean the District's alleys at least one time a week.

Tool Bank: There is a small tool bank available for residents to use for various garden and home improvement projects. Check out is limited to 3 days. For more information call our office at 410-235-4411 or email sanitation@charlesvillage.org

Rat Abatement Project: Monitor contract with extermination company to distribute and maintain 480 rat bait stations throughout the District, and distribute flyers and conduct educational workshops to inform residents what measures they can take to help abate rats.

- Old Goucher: NE corner of 23rd and Hunter

The CVCBD will have a limited amount of bags, brooms, shovels, & garden tools available at each location for residents to use for this event. CVCBD staff will be at each site to assist residents in putting trash & refuse into the dumpster.

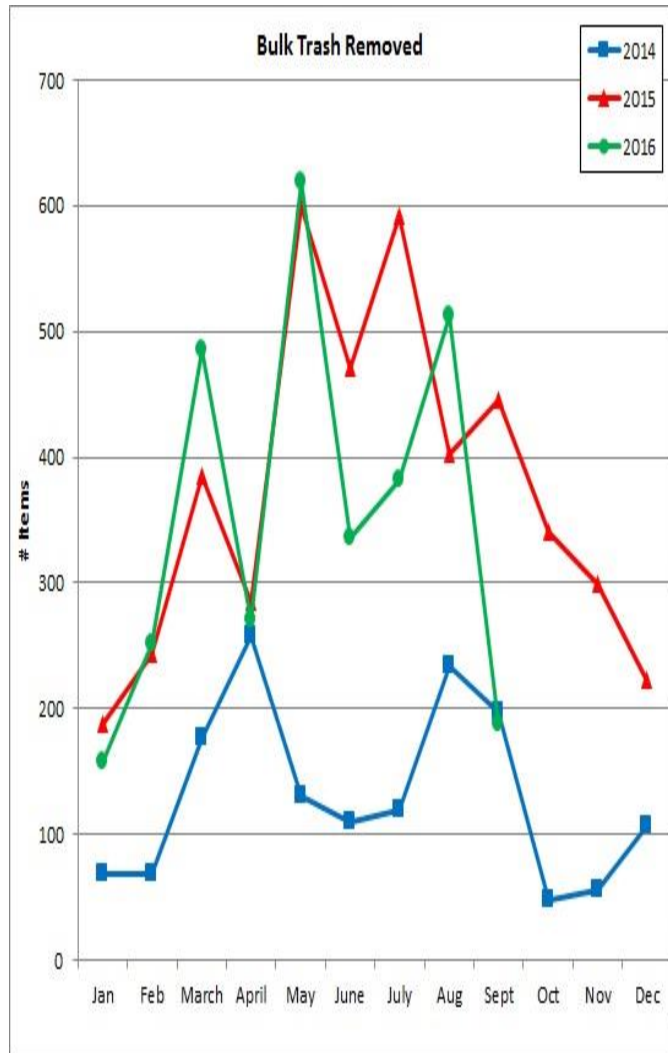
