

Baltimore Police On-line Reporting for Non-Violent Crime

Mayor Rawlings-Blake, Police Commissioner Batts and Councilman Brandon Scott unveiled the City's new citizen on-line police reporting system. The system allows Baltimore crime victims to file reports on-line for non-violent incidents such as car break-ins, vandalism and illegal dumping. Reports can also be filed on various platforms including a computer, tablet or smart phone. All the user has to do is go to the city police website, and click the reporting link and follow instructions. Each report is assigned an incident number, and the user gets a PDF file of their report that can also be used to report loss for insurance.

In the past two weeks we have had a rash of car breakins in the CVCBD. This larceny problem is driving the entire crime rate higher each week. The Northern District Officers are doing a good job with combating violent crime in our area but they need our help in preventing this crime of opportunity within our community. After speaking with the Northern District Commander Captain Wells about this crime pattern of larceny from autos, we found one common denominator and that is most items stolen are items lying in plain view on the car seats such as purses, wallets or computers. It only takes a few seconds for someone to smash a window and reach into a vehicle to remove this property. The thief cannot know the exact value or the actual contents but will seize this opportunity to benefit themselves for any type of gain that may appear to be rewarding. Please remember the below points and share this message with your neighbors.

Always check your vehicle and take items that may be valuable with you.

Do not leave items in your vehicle just to run into a store or residence for a short time. It only takes seconds to steal.

Do not leave empty boxes or gym bags lying in plain view.

Do not leave indicators such as suction cups marks on windows or phone charging cables in view.

If you observe someone walking by vehicles and pulling on door handles, this is suspicious activity. Call 911.
